## COLLABORATION AGREEMENT

Between

## the University of Windsor

and

## the University of Chile

WHEREAS the present agreement establishes the basis for cooperation between the University of Chile and the University of Windsor, is intended to develop mechanisms for mutual collaboration and to concentrate efforts and resources available to facilitate the advancement of knowledge, culture, scientific research and technology; and

WHEREAS it is beneficial for both institutions to encourage the exchange and the establishment of joint academic programs, carry out research and joint activities in areas of mutual interest; and

WHEREAS the academic exchange and research collaboration is clearly of benefit for both parties in order to achieve specific goals within the disciplines where the activities take place; and

WHEREAS the agreement will encourage the formulation and execution of joint programs and research projects, teaching and graduate studies that shall contribute to the enhancement of teaching, research and community services within each university.

The University of Chile, represented by the President Dr. Jaime Lavado Montes, located in Avenida Libertador Bernardo O'Higgins No. 1058, Santiago and the University of Windsor, 410 Sunset, Windsor, Ontario, N9B 3P4, represented by the President, Dr. R.W. Ianni have agreed:

- 1. To identify the areas or themes of common interest with the purpose of formulating projects for common development.
- 2. That the terms of each project and the conditions thereafter or the exchange programs shall be stated in specific agreements that will be an addendum to the present agreement.
- 3. That the specific agreements mentioned above, should contain a description of the project, objectives, academic units involved, conditions, financial support, terms, responsibilities and other needs necessary for the realization of the program.
- 4. That the parties shall promote the academic exchange between both universities, using courses, conferences, invited lectures or other activities that would contribute to the academic improvement and would serve the common interest of both universities.

- 5. That the parties will exchange information about activities such as Symposia, Seminars, etc. as well as of visiting professors and researchers that could be of interest to both universities.
- 6. That, for the financial support of research that falls within the frame of the present agreement, the parties will seek support from national and international organizations, and ask their cooperation in the implementation of joint programs. External funding shall avoid any economic burden for both institutions.
- 7. That the intellectual property of any joint investigations shall be owned by both institutions and may be published by either of the parties with appropriate reference to the specific project and with prior notification to the other party.
- 8. That the parties will decide on the most efficient way of selecting participants in the program(s) as to ensure success and continuity.
- 9. That both institutions will regularly evaluate the projects of collaboration and the input of both universities.
- 10. That the universities will make available both the facilities and equipment for the development of joint projects.
- 11. That the parties will appoint the Vice-President, Academic of the corresponding university, or whoever may be authorized to represent them to supervise the implementation of the agreement, and to formulate and control the specific projects in accordance with the procedures and formalities required by the rules and regulations of each institution.
- 12. That the present agreement will be indefinite. However, either of the parties may revoke the general agreement with a notification given to the other party sixty days in advance.
