**Memorandum of Understanding Regarding Academic Cooperation
Between**

**The University of California San Diego, Health Sciences,
La Jolla, California, USA**

and

**The Universidad de Chile, Facultad de Ciencias Químicas Y Farmacéuticas
Independencia, Santiago, Chile**

This Memorandum of Understanding is entered into this first day of November, 2006, by and between, the Regents of the University of California, on behalf of the University of California, San Diego School of Medicine, located in La Jolla, California, USA ("UCSD"), and the Universidad de Chile, Facultad de Ciencias Químicas Y Farmacéuticas in Independencia, Santiago, Chile ("UCCQF") and its faculties of Science and Pharmacy with respect to the following:

Whereas, UCSD and UCCQF seek to establish a closer relationship in order to foster collaboration between both educational institutions with the goal of participating in academic, scientific and cultural activities in areas of common interest, and;

Whereas, the objective of this agreement is to promote a cooperative spirit which will enhance the goodwill which characterizes the relationship between our two countries, and;


Towards achieving these objectives, UCSD and UCCQF agree to the following goals:


- a. to improve educational and instructional opportunities between the two institutions to create collaborations of mutual interest in diverse areas of science, pharmacy and public health.
- b. to create opportunities for intellectual and professional advancement of our faculties.
- c. to share expertise and experience to further scientific and academic interaction between the two institutions, to complement their respective areas of expertise, and to enhance their respective missions to deliver the very best in translational research toward the goal of improving human health.

The term of this agreement is for the period from March 1, 2007 through February 29, 2012. This Memorandum of Understanding may be renewed upon the mutual written agreement of both parties. This agreement may be terminated without cause, for an reason, at any time by either party upon ninety (90) days prior written notice, provided, however, no termination should adversely interrupt or impair a program or course of study or its participants, commenced prior to such termination.
